The Mansfield Economic Development Corporation is authorized to use previously approved collections of its sales and use tax, including all amounts already collected, for projects related to recreational or community facilities, including but not limited to, land, buildings, equipment, facilities and improvements found by the board of directors to be required or suitable for use for professional and amateur sports, including children's sports, entertainment, tourist, convention, public park purposes and events, auditoriums, amphitheatres, parks and park facilities, open space improvements, related store, restaurant, concession, automobile parking facilities, related transportation facilities, related roads, streets, water and sewer facilities, other related improvements that enhance these projects, any other projects or improvements found by the corporation's board of directors to promote new or expanded business development, and maintenance and operating costs associated with any of the above detailed projects.
