The commission also recommends changes to the city's zoning and subdivision ordinances, comprehensive land use plan and impact fee requirements. Members of P & Z also serve as the Capital Improvements Advisory Committee.

Mansfield Economic Development Corporation

The MEDC administers the half-cent sales tax authorized by voters to promote economic development in the city. The board directs and coordinates the broad-based expansion of the business and commercial tax base of the city, as well as promotes job growth and quality development in Mansfield.

Mansfield Park Facilities Development Corporation

The MPFDC administers the half-cent sales tax authorized by voters to develop and maintain the city's parks and recreation system. The board identifies facilities, projects and programs designed to improve the quality of life in Mansfield and encourage conservation and preservation of open spaces within the city.

Historic Landmark Commission

HLC considers applications for Certificates of Appropriateness for exterior alterations of historic landmarks or new construction of property within the historic overlay district. It also assists in the preservation of historic Mansfield through programs and projects, as well as through the designation of local historic landmarks, and increases public awareness of the value of historic, cultural and architectural preservation in the city.

The Library Advisory Board

advises the city council on issues and matters related to services provided by the Mansfield Public Library. The board also works with the Friends of the Mansfield Public Library, a volunteer organization providing support for library services.

Keep Mansfield Beautiful Commission

Established in 1986 to show local support of the Keep America Beautiful system, KMBC works actively in the community to encourage residents and businesses to beautify their property. The commission sponsors several beautification programs including adopt-a-street, spring and fall clean-up efforts, household hazardous waste collection program and SmartScape education classes.

Zoning Board of Adjustment

5 members, two alternates;
two-year terms

The ZBA hears requests for variances and special exceptions to the requirements in the city's zoning ordinance, and decides on appeals when it is alleged there is an error in any order or decision of the zoning administrator.

Construction Codes Board of Adjustment and Appeals

14 members, two-year terms
Meetings: as needed
City Hall, 1200 E. Broad St.

This board considers requests for variances from the application of any provision of the construction codes, hears appeals from building officials' decisions, and implements Section 150.011 "Dangerous and Substandard Structures" of the Code of ordinances. Eleven of the fourteen members must be involved in specific trades and three are selected at large from the building industry.
